Afterward, I completed my undergraduate education at Bilkent University Faculty of Law in 2014. After one year of legal internship, I worked as an active lawyer for 3 years in the fields of energy, information technologies, and space law.

During my university education, I participated in such social activities for strengthening education in disadvantaged regions of Turkey.

In 2014, in the AK Party's Youth Congress, which is the most inclusive youth movement of Turkey with its 1.5 million members, I was elected as the Vice President in charge of Public Relations. In the meantime, I traveled around various cities of Turkey and arranged well-attended, common wisdom meetings with non-governmental organizations.
